Policies for Students Participating in TMEA Region 3 All-Region Orchestra Events

The following policies and procedures are in addition to or in concurrence with current policies and procedures required by TMEA as of August 2017. To review a comprehensive list of region policies and requirements for directors and students please visit the region website at www.region3orchestra.org.

1. A complete list of audition material is available on the region website. Please see a region director for audition specifics. Auditions may include region excerpts, All-State etudes, and/or scales.
2. No student shall interfere with another audition or prohibit any student from performing to the best of their individual ability. Should a student cause a disturbance to the audition process, monitor and judges may remove this student from the entire audition process.
3. Students must check in with their room monitor at least thirty (30) minutes before their audition time. Students who arrive late may not be allowed to participate in the audition.
4. In the event that the applicant becomes a member of the Region III Orchestra, the applicant agrees to attend and be on time to all Region events.
 - a. Tardiness to Region Orchestra events may result in the loss of chair placement and/or removal from Region Orchestra, at the discretion of the Region III Orchestra Chair.
 - b. Conflicts with other organizations, personal schedules conflicts, etc. will not constitute a reasonable excuse for missing any activities in this region. No exceptions will be granted to this policy. Failure to attend any rehearsals will result in immediate loss of membership in the orchestra.**
 - c. Extreme emergency situations will be evaluated on a case-by-case basis by (and at the discretion of) the Region Chair. The Region Chair must be notified of such special circumstances immediately.
 - d. Personal illness, hospitalization and doctor's notes will be dealt with individually at the discretion of the Region Chair. The Region Chair must be notified of such special circumstances immediately.
5. Prior to the audition, applicants and their parents/guardians must complete and sign a TMEA Region 3 Orchestra Audition Contract and return it to their director/sponsor. These will be submitted to the Region Chair with their audition entries.

Absolutely no deviation from this schedule will be allowed. If you cannot meet these obligations, please do not apply for or accept membership into the All-Region Orchestra
